

# Northmont Intermediate Color Guard Financial and Fundraising Agreement (FA)

## 2016 Payment Schedule and Fundraising Overview:

Northmont Band Boosters (NBB) incurs many costs in advance on behalf of its component programs. For this reason, there can be no refunds after January 12, 2016 for any reason as many expenses are prepaid.

All families with students participating in the 2016 Northmont Intermediate Color Guard Program (NICG) are expected to meet the payment schedule in this agreement. Parents of any student with financial difficulty or that have difficulty fulfilling their Booster Support Events (BSEs) must contact the Northmont Band Boosters (NBB) Student Accounts Coordinator, President or Marching Band Director either in person, by phone or via email ***in advance of due dates*** to discuss options. **The NBB is committed to working with you, please assist us in helping you by discussing BSE or payment issues in a timely, proactive manner.**

If you are planning to buy out of the BSEs instead of actually working them, please notify the Student Accounts Coordinator **IN WRITING** no later than January 12, 2016. Deadline to buyout of NICG BSEs is January 12, 2016.

***NOTE: Student accounts with past due balances from are required to be current, i.e.: zero (\$0) balance, or your account may show a credit, in order to be assured a spot on the floor for the 2016 Color Guard season. If you have questions, see the guard director.***

## 2016 NORTHMONT INTERMEDIATE COLOR GUARD PARTICIPATION FEES - \$410

The NBB is a self-supporting, 501(c)3 organization. The NBB generates the financial resources to support almost all aspects of the program since Northmont City Schools provides only minimal financial support. The NBB has been able to maintain current programming while attempting to keep fees level.

### Your Fees Cover:

- A high level of performance opportunities on a local and national level
- A talented team of instructors to coach you to success
- Equipment/props for a competitive show on a national level (floor/flags/props)
- All entry fees and circuit dues on a local and national level
- Two pairs of gloves
- 2016 NICG Show Shirt
- Supplies needed for the competition show
- Music arranging/copyright fees
- Hotel stays for overnight events
- Rehearsal space

### Out of Pocket (or Out of Account, if funds are available):

- Costume
- Shoes (if used in winter)
- Equipment accessories (tape, etc.)
- Wind suit (If you are a new member, you need to buy this)
- Makeup/hair accessories

## Color Guard Payment Options:

Your signed Financial Agreement (the last page of this document) must be received by Tuesday, January 12, 2016 deadline to assure your child is included in the final written drill for the 2016 Color Guard Show.

1) **Payment in Full:**

All 2016 Color Guard Fees of \$410 can be paid in full at any time prior to March 8, 2016.

2) **2016 Extended Payment Plan:**

- **November 20, 2015** - \$50 Deposit is due
- **Tuesday, January 12, 2016:** **\*\*\*NO REFUNDS AFTER THIS DATE\*\*\***
  - Signed Financial Agreement is due
  - \$150 First payment is due
  - Deadline to buyout of NICG BSEs
  - All medical forms are due
  - *If you have participated in SCRIP or other fundraising, credit from those events which appear in your child's account will automatically be applied against current fees owed. If the credit is less than current fees owed, you will owe the difference.*
- **Tuesday, February 10, 2016:** \$150 Second Payment is due
- **Tuesday, March 8, 2016:** \$60 Final Payment is due

\*\*\*The Northmont Band Boosters is a non-profit 501(c)3 tax exempt organization. Should a refund be requested by a Booster member from a student account, the only refund we are permitted to make prior to the January 12, 2016 deadline are those payments that are made directly by the Booster member into the student account. **No refund can be made for any funds credited through fundraising such as (but not inclusive): flower, sub sales or SCRIP program.**

## Fee Payment: Booster Meeting = Payment Due Dates

The following payment options are available:

Option #1: Pay at the Booster meetings using check, money order or credit card with no transaction fees. Please make check or money order payable to NBB with student's name on the memo line.

**To ensure timely posting to your account, please do not give payments to the guard director or program staff!!!**

## **NSF Checks:**

1. NSF or other fees for returned checks charged to the NBB will be passed on to the member involved.
2. Any check that is returned from the bank as NSF will be charged the appropriate NSF fee as allowed under Ohio Statute 2913.11. A collection agency, contracted by NBB, will be utilized to recover all monies in question.
3. These charges will be placed on account and will be treated as fees for the purposes of collection as described elsewhere in this document until they have been collected.

## **Account Review:**

Collection of fees is critical to NBB financial stability. All active NBB accounts will be reviewed in advance of the February 2016 NBB Meeting. Board Members will follow up on accounts showing non-payment of fees or BSE inactivity to date. If **written**, mutually-agreed-to efforts to address past due balances or missing BSEs are not evident by the January 2016 payment deadline, your student may forfeit his/her spot in the 2016 Color Guard Show. Because of program expenses, all monetary fees must be paid off by the March 2016 Booster meeting UNLESS other arrangements have been made with the board regardless of any outstanding (sweat equity) BSEs. Failure to pay out of pocket payment fees may result in the student forfeiting his/her spot in the program. BSE inactivity for all events will be reviewed on an ongoing basis.

**Student accounts must be in good standing (BSEs up to date and participation fees paid in full) in order to participate in the this program, other NBB affiliated programs or receipt of awards earned throughout the NICG season. All 2016 NICG BSE requirements must be fulfilled by April 30, 2016. Those with unfulfilled BSEs will not be eligible to participate in the 2016 Marching Band season or other future NBB sponsored programs. Collection proceedings will be initiated as allowed under the laws of the State of Ohio.**

## **Statements:**

Statements will be available anytime online using the Booster Charms system. Please review your statement carefully. Our goal is to be current with statement activity. Report missing activity promptly to the Student Accounts Coordinator for research and/or correction.

## **Fundraising Opportunities:**

The NBB utilizes a two-tiered approach to finance the various Northmont Band Programs. One tier is through fees which can be offset through participation in fundraising events. A variety of fundraising opportunities are offered throughout the year and Booster members are encouraged to take advantage of them. The second tier is through Booster Supported Events (BSEs), which involves sweat equity by the Booster member for the Booster organization to earn the needed funds to pay for the band program expenses. For example, the Northmont Band Boosters are contracted with the Athletic Department to run the concession stand for stadium events. In addition, there are several other BSE events where the Booster members are needed to volunteer their time to work shifts so that the Booster organization earns needed funding. For those Booster members who have challenges participating in the BSEs, we would encourage you to enlist the support of other family members or friends to work the BSEs or contact a board member to discuss options.

## **2016 Northmont Intermediate Color Guard Booster Supported Events (BSEs):**

Northmont Intermediate Color Guard would not be what it is without the sweat equity contribution by the member families. Each family, regardless of number of students, is required to participate in the following Booster Support Events (BSEs). If these BSEs are not fulfilled, the following surcharges will be applied to your student's accounts:

- **One (1) Committee participation of the following (description on Charms):** **\$100 surcharge**
  - Tarp Crew
  - Hospitality
  - Fundraising
  
- **Two (2) UD Arena Concession shifts** **\$75/each - \$150 total surcharge**
  
- **Participation in fundraisers** **\$75 surcharge**  
 Participation is defined as a Booster member who actively takes part in any or all of the Booster fundraising, such as buying/selling subs, buying/selling flowers, buying gift cards through the Boosters Scrip program, etc. Participation in any of the approved fundraising activities that will bring in revenue to the student account and/or the Boosters general account.

BSEs are investments of time and are not always easy or a preferred way for you to spend your personal time, but are critical to the success of the NBB program. BSEs are a great way to meet others in the organization (other Booster parents and students) and get involved in NBB. Surcharges assessed for BSEs not completed should not be viewed as a penalty or tax - these surcharges may pay for penalty fees assessed to the NBB by groups we contract with for not staffing a contracted event, or revenue lost by the program because of inadequate staffing.

## 2016 Northmont Intermediate Color Guard Financial Agreement

They also understand that their student's account must be current, without a past due balance, to be assured a position in the 2016 Northmont Intermediate Color Guard Show, and going forward must be current, without a past due balance, to participate in the 2016 Marching Band program or other future NBB sponsored programs.

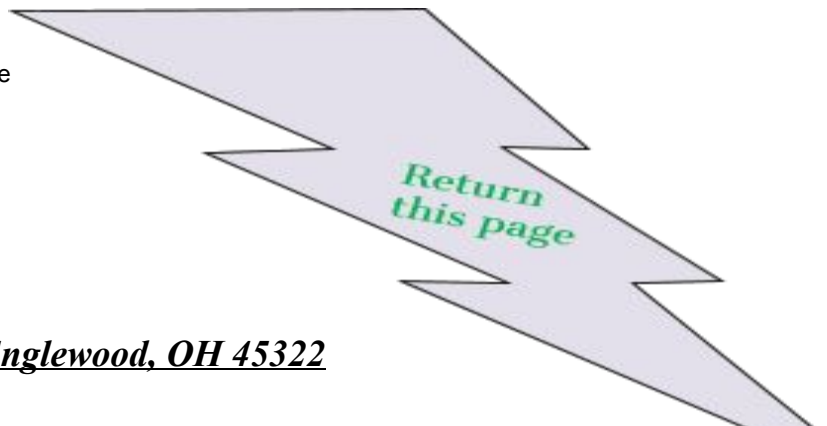
